


#### **Recommended Reflow Solder Profiles**







# **TYPICAL CHARACTERISTICS CURVES**






Fig 9: Collector Current  $I_C = f(V_{BE})$ 





Fig 10: Transition frequency  $f_T = f(I_C)$



# Recommended Product Storage Environment for Discrete Semiconductor Devices

This storage environment assumes that the Diodes and transistors are packed properly inside the original packing supplied by CDIL.

- · Temperature 5 °C to 30 °C
- · Humidity between 40 to 70 %RH
- · Air should be clean.
