










- 3. EMITTER



- 2. Maximum non-cumulative variation between tape feed holes shall not exceed 1 mm in 20 pitches
- 3. Hold down tape will not exceed beyond the edge(s) of carrier tape and there shall be no exposure of adhesive.
- 4. There will be no more than three (3) consecutive missing components in a tape.
- 5. A tape trailer, having at least three feed holes are provided after the last component in a tape.
- 6. Splices should not interfere with the sprocket feed holes.

Recommended Product Storage Environment for Discrete Semiconductor Devices

This storage environment assumes that the Diodes and transistors are packed properly inside the original packing supplied by CDIL.

- · Temperature 5 °C to 30 °C
- · Humidity between 40 to 70 %RH
- · Air should be clean.
- · Avoid harmful gas or dust.
- · Avoid outdoor exposure or storage in areas subject to rain or water spraying .
- · Avoid storage in areas subject to corrosive gas or dust. Product shall not be stored in areas exposed to direct sunlight.
- · Avoid rapid change of temperature.
- · Avoid condensation.
- · Mechanical stress such as vibration and impact shall be avoided.
- · The product shall not be placed directly on the floor.
- · The product shall be stored on a plane area. They should not be turned upside down.

They should not be placed against the wall.

Shelf Life of CDIL Products

The shelf life of products is the period from product manufacture to shipment to customers. The product can be unconditionally shipped within this period. The period is defined as 2 years.
